In 1856 Hindu Windom re-marriage also act XV. The introduction of the window re-marriage act was a major change in the state of women that prevailed during that period. Ishwar Chandra Vidyasagar played a major role in the establishment of the act. Before time only the male progeny had the right on property and land Ownership, but there was a fight against patriarchal society and inheritance law was passed in 1956(7).

In 1986 the national policy on education was formulated in India. The government launched a programmecalled 'MahilaSamakhya' focusing on the women empowerment.

Article 15[3] makes it possible for the state to create special provisions for protecting the interests of women and children.

Article 39 requires the state to direct its policy towards securing for men and women equally the right to an adequate means to livelihood article 39(a).and equal pay for equal work for both men and women [39d](8).

Article 51A[e] enjoins upon every citizen to renounce practices derogatory to the dignity of women.

She fought to the death dying in battle after refusing to surrender. Her strength and bravery made her a legend in Indian culture.

Savitribai Phule [1831-1897]One of the first generations modern Indian feminists. She was the first female teacher and head-mistress. They also fought against the caste system and welcoming untouchables who were disavowed drinking water by the upper caste. She was the social reformer of the 19th century. Her contribution revolved around rationality and human reasons such as truth equality and humanity.

Vijaya Lakshmi Pandit[1900-1990]She was the first Pre-and Post-Independence cabinet minister and the first ambassador to three different countries [Moscow,London,Washington D.C].And the first Asian Women who elected the President of the UNGA. In 1979 she was appointed the India representative to the UNHRC.

Kamala Devi Chattopadhyay[1903-1988]She was major contribution to India's Independence movement and advocate for women's equality. She organized the India Cooperative Union, this union helping rehabilitate over 50,000 refugees in the newly founded township of Faridabad. She became a founding member of the 'All India Women's Conference'.

Sucheta Kripa Lani [1908-1974]She was elected to the Constituent Assembly as part of sub-committee who helped draft India's constitution. She was elected the chief minister of Uttar Pradesh in 1963 the first female chief minister in Indian history. She was also the founder of the 'AllIndiaMahilaCongress' in 1940.

Justice Anna Chandy[1905-1996]She was the first female Indian judge and appointed to a district court 1937 and high court 1959. She was the founded of "Shrimati" a magazine which aimed to promoted the women's rights.

Usha Mehta[1920-2000] An Indian freedom fighter, she is also re-membered for organizing the congress Radio. There first words broadcast in her voice were "This is the congress radio calling on 42.34 meters from Somewhere in India."

Medha Patkar[1954-till date] Patkar has led the fight against numerous development projects in India. Her profession is social worker. And famous founding 'Narmada BachaoAndolan' and 'National Alliance of people's movement.

Kiran Bedi[199-till date]The first women to join the Indian Police Service[IPS] in 1972. In 1984 she lunched the NGO 'Navjyoti'India foundation whose goals was to the recovery and rehabilitation of drug addicts and women's empowerment issues. And director general of Bureau of Police research and development and police adviser UN police.
